CENTRAL GOVT. SCHOLARSHIP SCHEMES

FINANCIAL ASSISTANCE FOR EDUCATION TO THE WARDS OF BEEDI/CINE/IOMC/ LSDM WORKERS (POST-MATRIC) –GOI (UNDER NSP)

Eligibility Criteria:

- ❖ Either of the parents of the students should be Beedi, Iron Ore Manganese & Chrome Ore Mines, Limestone & Dolomite Mines, Cine worker with at least six months service.
- ❖ Students have an annual family income that does not exceed ₹1,20,000 per annum.
- ❖ The Applicant must have passed the last qualifying examination in first attempt.

- ❖ Students annual family income should be less than Rs. 8 lakhs.
- ❖ Maximum two girl child per family are eligible.

- ❖ Only two children form the same parents can take benefits for this scholarship.

EDUCATION ASSISTANCE FOR KARNATAKA BUILDING AND OTHER CONSTRUCTIONS WORKERS CHILDREN- GOK(SSP)

Eligibility Criteria:

- ❖ Students must be permanent resident Karnataka.
- ❖ The Parent of the student must be a registered under Karnataka State Building and other Construction workers Welfare Board.
- ❖ Only two children from the family will get the assistance.
- ❖ The General Category students must have minimum of 50% and the SC/ST must have 45% merit in their previous academic year.
- ❖ Students annual family income should be less than Rs. 2 lakhs.

KARNATAKA LABOUR WELFARE BOARD SCHOLARSHIP

Eligibility Criteria:

- ❖ Students should be residents of Karnataka state.
- ❖ 50% marks for general category candidates and 45% for SC/ST category candidates are the eligibility criteria to apply for this scholarship.
- ❖ To avail this benefit either father or mother of the student must be a registered under the Karnataka Labor Welfare Department and pay welfare fund to it.
- ❖ To avail the scholarship parent the monthly income should be 35,000 or below.

Eligibility and Conditions:

- ❖ Students should have minimum 60% marks or equivalent grade in the previous final examination.
- ❖ Scholarship shall not be given to more than one student in a family.
- ❖ Selection of LIC Scholar will be on the basis of merit and family background such as percentage of marks in class 12th /10th and annual income of the family.

- ❖ Must have scored at least 60% marks in previous exam. Annual family income must be less Rs. 3 lakhs.
- ❖ One of the parents should be a driver (all light motor vehicles and small commercial vehicles.) and should hold a valid driving license.

IMPORTANT INSTRUCTIONS

- ❖ The name of the student in the Aadhaar card, bank account, and income & caste certificate **must exactly match** the name in the SSLC marks card.
- ❖ The student's bank account **must be active and operational** until the scholarship amount is disbursed.
- ❖ To continue receiving the scholarship benefit, the **student's bank account must be linked to their Aadhaar** and properly **mapped with NPCI** (National Payments Corporation of India).
- ❖ Ensure that the **mobile number registered with Aadhaar is active**, as the OTP will be sent to that number. If not, **update the mobile number linked with Aadhaar immediately**.
- ❖ **Check the validity period** of the income and caste certificates and ensure they are valid at the time of application.
